APPLICATION UNDER THE *FREEDOM OF INFORMATION ACT 1991*

I refer to your application made under the *Freedom of Information Act 1991* (the FOI Act) dated 10 March 2021, seeking access to:

“Copy of the modelling referred to in the final paragraph (see attached).”

A search for documents held by the Minister for Innovation and Skills was undertaken and one document was identified within scope of your application.

Document 1 contains speaking notes prepared for use in Parliament. Under Schedule 1 clause 17 the FOI act states the following:-

A document is an exempt document if it contains matter the public disclosure of which would, but for any immunity of the Crown –

(C) infringe the privilege of Parliament.

I have reviewed the document and determined to refuse access in accordance with clause 17 (c) Schedule 1 of the FO Act as the content is a privilege of Parliament.
