I refer to your application to the Office of the Minister for Innovation and Skills made under the *Freedom of Information Act 1991* (the FOI Act) on 17 July 2019. Your application sought access to:

“Copies of any and all documents (including but not limited to physical, electronic, or handwritten correspondence, letters, emails, briefs, minutes, diary entries and any other correspondence) between the Minister and/or the Minister’s staff and Ms Nicole Flint and/or the Liberal for Boothby campaign.”
